VETERANS' CORNER

Veterans Prescription Fraud Alert

It has been reported that veterans are receiving calls from a company identifying itself as the "Patient Care Group." This company is claiming that veteran's prescriptions are now being dispensed through them and if they (veterans) want to continue to receive their meds, they will need to provide a credit card number.

Veterans are advised that the VA has not changed the process of receiving and dispensing prescriptions. Veterans are also advised to never give out their personal information, including social security or credit card numbers, to any organization without first verifying their legitimacy.

Stop Medicare Reductions in Physicians Reimbursements. Stop Medicare Physicians Payments Cuts and Protect Patients

Contact your legislators today! (Not tomorrow!)

We know you're busy, but here are a few quick facts to ponder. If you are a military retiree under age 65, please take particular note of Fact 4.

Fact 1: Congress has only a few weeks left in this year's legislative session to stop Medicare Law from cutting your physician payments by 4.4% on Jan. 1, 2006.

Fact 2: If this cut occurs, the average Medicare physician payment rate in 2006 will be less than it was in 2001. If physicians are already refusing new Medicare patients, then this cut will hasten the process.

Fact 3: If Congress doesn't fix the underlying payment formula, Medicare Law will slash what it pays physicians who treat America's seniors by 26% over the next six years. This means that in six years, or before, you will be hard pressed to find a physician who will accept Medicare.

Fact 4: TRICARE reimbursement rates are directly controlled by the corresponding Medicare reimbursement rates. This means that if you are a military retiree under age 65, this upcoming change in Medicare rates will directly impact you even though you are not yet eligible for Medicare! If many physicians are already refusing TRICARE Standard patients, think of what the situation will be like in six years.

Fact 5: Time is running out. It's critical that Congress hear from you and your colleagues TODAY! There are three bills in Congress--S 1081 in the senate and H.R. 2356 and H.R. 3617 in the House--that would protect America's patients by stopping drastic Medicare physician payment cuts over the next two years. Tell your representatives to stop Medicare physician payment cuts by supporting these bills.

Even if you have already contacted your two senators and one representative about this issue in the last week or two, you must do so again. On active duty we were a team, let's become a team again and tell Congress how the Medicare cuts will affect your quality of life as military retiree or senior citizen.

included. If you plan on attending PLEASE return
this form early. The hotel will release 1/2 our
reserved rooms 60 days out and the rest 30 days out.
Don't find yourself without a room. Also, a decision
on the size of the hospitality room has to be made 60
days out. We don't want to be crowded; however, to
order a room larger than we need wouldn't be fair to
the hotel. A \$50 deposit will be required with your
reservation. A charge card will be accepted. Should
you have to cancel, you will be refunded \$40.

Some brief highlights: there will be a welcome reception, a continental breakfast each AM, sightseeing, Veteran's Memorial Museum, 3 shows-one of them being a dinner cruise, a banquet, and a group photo for everyone prior to departure.
