VETERANS' CORNER

2009 COLA for Retired Pay

Each year, military retirement pay is adjusted to meet the increased cost of living. This cost-of-living-adjustment (COLA) varies from year to year based on the previous year's Consumer Price Index (CPI).

2009 update: The 2009 military retired pay cost-of-living-adjustment (COLA) will be 5.8%.

This increase, which goes into effect on December 1, 2008, also applies to SBP annuities, Social Security checks, and VA disability and survivor benefits. Retirees will see the increase in their January, 2009 checks.

NOTE: This annual cost-of-living-adjustment is **NOT** in any way related to the annual military pay raise for active duty and reserve service members. In fact, this year's COLA increase is larger than the 2009 military pay raise of 3.9%.

All retirees who retired before January 1, 2008 will receive the **5.8 percent** cost-of-living-adjustment.

MASSEY HISTORY

Gordon Risk, Historian

(The following was submitted by **William B. Wilmer, LTJG, 51-54**).

... I loved the story about Don Carten, FTSN and his watches.

I went aboard Massey as an Ensign in July, 1951, the day she returned to Norfolk from Korea. There were three of us new ensigns, one from US Naval Academy, one from Yale, and me—Duke. The captain loudly announced in the wardroom that we three had the duty for two days and all officers were given liberty. So started my career.

After a few months, I became Navigator, ASW Officer, and Electronics Officer (all at the same time). Once, during this period, we were abruptly ordered to sea one Saturday morning to relieve another destroyer that had collided with a carrier while refueling—relatively minor damage. Anyway, we scurried up the crew and were going down the channel, about at the NOB (Naval Operations Base) piers, when we came upon a tug & tow going the same way we were, but sort of hogging the channel. At the same time, USS IOWA appeared at the bend in Thimble Shoal Channel. Our captain had the con. I was Navigator. He started to pass the tug & tow on his port side.

About then, IOWA accelerated (puff of black smoke) and turned into the channel. Now since there was no room for us all there, the captain, to his credit, gave all ahead flank and we charged past the tug and tow, swerved to starboard, then back to port to swing around IOWA, whose signal light was saying nasty words—I could read light at that time. As we skimmed down IOWA's port side, I know I could have thrown the pencil I had in my hand onto her main deck.

A year or so later, while doing ASW exercises—I was Operations Officer (LTJG) and Electronics Officer and a qualified underway OOD (Officer of the Deck). We were doing night attacks-lights out with another destroyer on a submarine. This was a pattern attack. Anyway, the other DD disappeared from the radar monitor. The captain, who was on the bridge, had our lights turned on and there--right in front of us--was the destroyer. All back full, hard port rudder, and we missed each other by one coat of paint. Another job well done by the captain.

We all have our stories. In my three years onboard, we were the only ship in the division who did not have a major casualty. Robert K. Huntington (Bouncing Bobby K) was rammed by a coal collier, Zellars (Zipping Zee) lost a corpsman in a man overboard drill when the whaleboat bow davit line allowed the whaleboat to dive into the water, and the other DD had an ensign killed during refueling.

We were lucky—I'd like to say good. Best to all, Bill Wilmer, CDR, USNR (ret.)
